
RESOLUTION NUMBER R- 269187

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to renew, for and on behalf of said City, an agreement with the County of San Diego, Probation Department, to utilize Probation Department Crews to clean City-owned property, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR- 269187.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$59,800 from Litter Control Budget, General Fund, is hereby authorized, solely and exclusively for the purpose of providing funds for the renewal of the above agreement and further authorizing the City Auditor and Comptroller upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
