BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$59,121.87 from the Sewer Revenue Fund 41506, Capital Improvement Program, Annual Allocation for Sewer Main Replacements (CIP No. 44-001), is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.
