
ADOPTED ON SEP 8 1987

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$51,000 from CIP No. 29-445.0, Los Altos Neighborhood Park Development, Park Service District Fund Nos. 11720 and 16740, is hereby authorized, solely and exclusively for the purpose of providing funds for the execution of the above agreement and authorizing the City Auditor and Comptroller upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
