
ADOPTED ON SEP 8 1987

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$7,500 from CIP No. 29-450.0, Presidio Community Park Improvements (PSD Fund No. 15580), is hereby authorized, solely and exclusively for the purpose of providing funds for the execution of the above second amendment to agreement and authorizing the City Auditor and Comptroller upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
