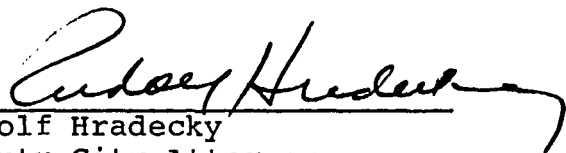
ADOPTED ON SEP 8 1987

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$40,000 from CIP No. 20-009, Miscellaneous Professional Services, Capital Outlay Fund No. 30245, is hereby authorized, solely and exclusively for the purpose of providing funds for the execution of the above agreement and authorizing the City Auditor and Comptroller upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
