
ADOPTED ON SEP 8 1987

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$16,590 from CIP No. 29-574.1, Paradise Hills Community Park Improvements, Phase I, (CDBG Fund 18521, Dept. 5833), is hereby authorized, solely and exclusively for the purpose of providing funds for the execution of the above first amendment to agreement and authorizing the City Auditor and Comptroller upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
