BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with PRC Engineering, for the design of ballfield lighting at Cadman, Kearny Mesa and Mira Mesa park sites, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR- 269200 .

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$23,871 (\$7,567 from CIP No. 29-559.0, Cadman Community Park - Lighting, Park Service District Fund No. 13430; \$9,738 from CIP No. 29-564.0, Kearny Mesa Community Park - Lighting, Park Service District Fund No. 11432; and \$6,566 from CIP No. 29-567.0, Mira Mesa Community Park - Lighting, Park Service District Fund No. 11222, is hereby authorized, solely and exclusively for the purpose of providing funds for the execution of the above agreement and authorizing the City Auditor and Comptroller upon advice from the administering department, to

transfer excess budgeted funds, if any, to the appropriate reserves.
