BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$37,500 from the Water Operating Fund (41500), Water Operation Engineering Program (70830) and \$37,500 from the Sewer

Revenue Fund (41506) Sewer Operation Engineering Program (70820), is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.
