

RESOLUTION NUMBER R- **269207**

ADOPTED ON SEP 8 1987

WHEREAS, since 1974, the Zoological Society (Society) has contracted with The City of San Diego to provide vector control services within the Zoological Exhibit as part of the Citywide vector control program; and

WHEREAS, these services are provided by the County under separate contract with The City of San Diego; and

WHEREAS, the current agreement with the Society provides for one full-time Vector Control Technician to service the Zoo and the immediate Balboa Park area, and the Society is charged for one-half of this staff position; and


WHEREAS, since the inception of the agreement, increased demands for vector control services within the Zoological Exhibit have arisen and the agreement needs to be amended to reflect the cost apportionment as provided by the County based upon actual services received by the Society; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an AMENDMENT TO THE AGREEMENT with the ZOOLOGICAL SOCIETY OF SAN DIEGO, to provide that the Zoological Society pay the City 100% of the total operating cost of vector control services for the Zoological Exhibit, under the terms and conditions set forth in the

amendment to the agreement, on file in the office of the City
Clerk as Document No. RR- 269207.
