He suggested changing the motors on the cooling tower for the City Operations Building serving the Communications Center. This is expected to save \$6,343.70, in energy costs. This is a partial award pending a 12-month review.
Joseph Ascitutto	General Services - Communications & Electrical	\$919.68	Mr. Ascitutto is a Fire Captain. He suggested relocating the unused traffic signal at Station #13. This idea saved \$3,065.60 in energy costs and salvage value. This is his full award.
