Barbara Thompson	Utilities	\$380.20	Ms. Thompson is Principal Clerk in the Customer Service Division. She suggested using an answering machine to convey locations of agencies accepting water bill payments. Actual savings of \$2,534.01 in time was realized. This is the remainder of her award.
Robert Hauptman	General Services	\$262.65	Mr. Hauptman is a Refrigeration Mechanic with the Buildings Division. He suggested changing the motors on the cooling tower for the City Operations Building serving the heat of the lighting system. This is expected to save \$1,751.00, in energy costs. This is a partial award pending a 12-month review.
Michael Dunn	Library	\$180.00	Mr. Dunn was a Library Aide with the extension Division at the time of this suggestion. He suggested attaching caution signs to the Library Bookmobile to alert drivers of the presence of children. Although savings are difficult to identify, this was considered to be a significant operational improvement.
