Jean Doucette	Police	\$45.00	Mr. Doucette is a Detective with the Vice Unit. He suggested placing a protective cover over the metal shroud in the police van that transports officers. Although savings are difficult to identify, this was considered to be a significant operational improvement.
Robert Sherer	Police	\$ 7.40	Mr. Sherer is a Stock Clerk with Northern Division. He suggested changing vendors for picture frames. This idea saved \$234.00 in unit prices. This is the remainder of his award.
