RESOLUTION OF INTENTION TO ACQUIRE OPEN SPACE LAND FOR THE SAN DIEGO OPEN SPACE PARK FACILITIES DISTRICT NO. 1.

- 1. - 3. That no park improvements to said property are presently proposed.
- 4. That on October 20 , 1987, at the hour of 10:00 a.m., in the Council Chambers, City Administration

 Building, Charles C. Dail Concourse, 202 "C" Street, San Diego, California; the City Council will hear any persons interested in the matter of the acquisition of said property and will consider and finally act on the acquisition of said property.
- 5. That the owner or owners of said property may appear at the hearing and be heard orally, or by writing signed by them,

and present evidence for or against the acquisition of said property by the District.

6. That a copy of this resolution shall be posted on the bulletin board of the City Administration Building and be published in a newspaper of general circulation, printed and published in the City once a week for two weeks, the posting and first publication to be on or before the 10th day prior to the day of hearing.
