BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to contract with Associated House Movers and Wrecking Company to move the donated building onto site adjacent to 5540 Kiowa Drive, and to waive the requirements for competitive bidding since no competitive advantage can be gained in view of the favorable costs to the City.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$18,000 from the Dams and Reservoir Program (703222), is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.
