for present public street purposes.

BE IT FURTHER RESOLVED, that the grade crossings at 54th Street (between Martin Luther King Way and Naranja Street) and 66th Street (between Imperial Avenue and Akins Avenue), as more particularly shown on the Project Location Map on file in the office of the City Clerk as Document No. RR-263261, be, and the same is hereby ordered closed to vehicular traffic.
