

RESOLUTION NUMBER R- 269283

ADOPTED ON SEP 21 1987

BE IT RESOLVED, by the Council of The City of San Diego that the low and low acceptable bids of 1. CARY K. SALES CO., INC., 2. STAR TOOL & SUPPLY, 3. KNOX INDUSTRIAL SUPPLIES, and 4. THE DONNER COMPANY, meeting specifications, are hereby accepted and the City Manager is hereby authorized to execute contracts for the purchase of SMALL TOOLS as may be required for a period of one (1) year beginning September 1, 1987 through August 31, 1988, per prices on file in the Purchasing Department, as follows:

1. CARY K. SALES CO., INC. for Section I - Files; terms 1% 20 days, plus sales tax, with an option to renew contract for two (2) additional one (1) year periods, with no price increase the first year and price increase not to exceed 5% of prices in effect at the end of the initial year for the second year.
2. STAR TOOL & SUPPLY for Section II - Miscellaneous; Section III - Hammers & Handles; Section IV - Pliers & Wrenches; and Section V - Shovels; terms 1% 30 days, plus sales tax, with an option to renew contract for two (2) additional one (1) year periods, with price increase not to exceed 5% of prices in effect at the end of the initial year for both years.
3. KNOX INDUSTRIAL SUPPLIES for Section VI - Screwdrivers & Miscellaneous; terms 1% 30 days, plus sales tax, with an option to renew contract for two (2) additional one (1) year periods, with price increase not to exceed 7% of prices in effect at the end of the initial year, the first year, and not to exceed 14% of prices in effect at the end of the initial year for the second year.
4. THE DONNER COMPANY for Section VII - Sockets & Socket Wrench Accessories; Section VIII - Impact Sockets & Accessories; and Section IX - Open, Box & Combination Wrenches; terms 1% 20 days, plus sales tax, with an option to renew contract for two (2) additional one (1) year periods, with price increase not to exceed 10% of prices in effect at the end of the initial year, the first year, and not to exceed 20% of prices in effect at the end of the initial year, the second year.
