RESOLUTION NUMBER R- 269293

ADOPTED ON SEP 21 1987

WHEREAS, the City of Santee has requested that the Council of The City of San Diego (the "Council") consent to the proposed Mast Boulevard Reorganization which would involve the detachment of an approximately 277-acre territory from the City of San Diego; and

WHEREAS, it has been determined that the detachment of 194 acres of said territory as identified in Planning Department Report No. 87-416 would be generally adverse to the interest of the City of San Diego at this time; and

WHEREAS, it has been determined that the detachment of 83 acres of said territory as identified in Planning Department Report No. 87-416 would effect a more logical boundary for the Cities of San Diego and Santee; and

WHEREAS, tax revenues received now and in the foreseeable future from the 83 acre territory are nominal; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that it hereby declares objection to the detachment of 194 of the 277-acre territory identified in Planning Department Report No. 87-416, proposed by the Mast Boulevard Reorganization.

BE IT FURTHER RESOLVED, that the Council does not oppose the detachment of the 83 acres identified in Planning Department Report No. 87-416; and further it will not exercise the authority available under Government Code Section 57079 with regard to the reorganization of the 83-acre territory.
