RESOLUTION NUMBER R-269308

ADOPTED ON SEPTEMBER 22, 1987

WHEREAS, MIDWEST TELEVISION, INC., by Douglas Garner, appealed the decision of the Planning Commission in denying Vesting Tentative Map No. TM-86-0575 submitted by MIDWEST TELEVISION, INC. and NOLTE AND ASSOCIATES ENGINEERING for a 33-lot subdivision on a portion of Lots 2 through 6, Block G, Fanita Ranch, Map No. 688, and portions of Tracts C and T, Rancho El Cajon, Map No. 262, located on the north side of Mission Gorge Road, between Mast Boulevard and Father Juniper Serra Trail, in the East Elliott Community Plan area, in the R1-40000 Zone; and

WHEREAS, the matter was set for public hearing on July 14 and continued to September 22, 1987, testimony having been heard, evidence having been submitted, and the City Council having fully considered the matter and being fully advised concerning the same; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council adopts and incorporates herein by reference the findings of the Planning Commission in Planning Commission Resolution No. 7081, adopted June 11, 1987, which are supported by the minutes, maps and exhibits, all of which are herein incorporated by reference.

BE IT FURTHER RESOLVED, that the appeal of MIDWEST TELEVISION, INC. is denied; the decision of the Planning Commission is sustained, and Vesting Tentative Map No. TM-86-0575 is hereby denied.
