A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO, CALIFORNIA, CONSENTING TO A JOINT PUBLIC HEARING ON THE PROPOSED FIFTH AMENDMENT TO THE REDEVELOPMENT PLAN FOR THE MARINA REDEVELOPMENT PROJECT, AUTHORIZING THE ESTABLISHMENT OF A DATE, TIME AND PLACE THEREFOR, AND AUTHORIZING PUBLICATION AND MAILING OF NOTICE OF SUCH JOINT PUBLIC HEARING.

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. The Council hereby consents to a joint public hearing with the Agency on the proposed Fifth Amendment to the Redevelopment Plan for the Project and hereby authorizes the Executive Director of the Agency, or his designee, to establish the date, time and place therefor.

2. The Executive Director of the Agency, or his designee, shall, in cooperation with the City Clerk of The City of San Diego, publish and mail notice of public hearing on the proposed Fifth Amendment to the Redevelopment Plan, in the manner, and with other documents as required and established by law.
