Steven Zeiss	Managers	\$5,000.00	Mr. Zeiss is an Electrician with the Stadium. He suggested adjusting the amount billed to Service America for electricity by adding in multipliers. The estimated savings in electricity payments is \$32,569.02. This is his full award.
Catherine Jagers Josephine Miller	Police	\$ 577.13	Ms. Jagers and Ms. Miller are Typist with the Traffic Division. They suggested storing three parking control vehicles at La Jolla. The actual savings in revenue is \$1,923.75. This is their full award.
John Trent	Police	\$ 500.00	Mr. Trent is a Police Officer II. He suggested replacing the narrative report for a drunk in public arrest with a check-off sheet. Although savings are difficult to identify, this was considered to be a significant operational improvement.
