Robert Herrmann	General Services	\$180.00	Mr. Herrmann is an Electrician with the Communications and Electrical Division. He suggested installing box dots on curb faces to identify location of boxes. Although savings are difficult to identify, this was considered to be a significant operational improvement. This is an additional intangible award and the remainder of his award.
John Chaffin	Utilities	\$160.00	Mr. Chaffin is an Associate Chemist. He suggested renting high pressure cylinders of high-purity gas. Although savings are difficult to identify, this was considered to be a significant operational improvement.
Carmen Lutes	Building Inspection	\$ 97.01	Ms. Lutes is the Principle Clerk. She suggested eliminating reporting clerical work units on the Bi-weekly work unit report. Estimated savings of \$323.35 is expected in time. This suggestion will be reviewed in a year.
