Mary Marino	Treasurer	\$86.61	Ms. Marino is a Data Entry Operator. She suggested the design of a program to facilitate the entering of payee data into the Parking Citation system. Actual savings of \$1,096.43 was realized in time. This is the remainder of her award.
Ernest DeLeon	Utilities	\$45.00	Mr. DeLeon is a Water Plant Operator. He suggested installing telephone answering machines at the three filtration plants. Although savings are difficult to identify, this was considered to be a significant operational improvement. This is an additional intangible award and the remainder of his award.
