BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer \$17,306 from Trust Deposit Fund 63021 (Conrock Co.) to CIP No. 52-328 FRIARS ROAD MEDIAN BARRIER.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$592,306 (\$575,000 from Gas Tax Fund 30219, and \$17,306 from Trust Deposit Fund 63021, Conrock Co.) from CIP No. 52-328 FRIARS ROAD MEDIAN BARRIER is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
