WHEREAS, The City of San Diego has been named as a party in a lawsuit against thirteen (13) California cities and counties which have prohibited or regulated onshore facilities for oil and gas development on the federal Outer Continental Shelf (OCS); and

WHEREAS, said lawsuit has been brought by the Western Oil and Gas Association (WOGA) and the National Ocean Industries

Association (NOIA) and is captioned Western Oil and Gas

Association, a nonprofit corporation, and National Ocean

Industries Association, a nonprofit corporation v. Sonoma County, et al.; and

WHEREAS, representatives of the named governmental jurisdictions agreed that a coordinated defense of the lawsuit was necessary and decided to engage Attorney Roger Beers, a litigator specializing in environmental law, for the purpose of representing the various named parties; and

WHEREAS, each jurisdiction was assessed a portion of the costs and it is necessary and appropriate to provide funds for defrayal of San Diego's portion; and

WHEREAS, the Council, in Closed Session on September 8, 1987, approved by a 6-0 vote the allocation of \$5,000 for the purpose of defraying legal expenses in said litigation; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the Auditor and Comptroller be and he is hereby authorized to

transfer within the General Fund 100, the sum of \$5,000 from the Unallocated Reserve (605) to the Allocated Reserve (901) for the purpose of defraying legal expenses in the case captioned Western Oil and Gas Association, a nonprofit corporation, and National Ocean Industries Association, a nonprofit corporation v. Sonoma County, et al., said case involving oil and gas development on the federal Outer Continental Shelf.

BE IT FURTHER RESOLVED, that the City Attorney be and he is hereby authorized to engage and execute a retainer agreement with Mr. Roger Beers, Attorney-at-law, with offices at 380 Hayes Street, Suite 1, San Francisco, California 94102, for legal services in connection with the litigation recited hereinabove.
