City of San Diego, et al., resulting from alleged loss of profits to Aztec Landscape Company.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller be and he is hereby authorized to issue one check in the amount of \$67,500, made payable to Aztec Landscape Company and its

92101-2514, in full settlement of the lawsuit and of all claims,
said payment to be made from the General Fund 100, Department
