RESOLUTION NUMBER R- 269354

ADOPTED ON SEP 28 1987

WHEREAS, the Regional Urban Information System (RUIS) is an automated geographic information system being developed jointly under an agreement executed in May, 1984, between the County of San Diego, The City of San Diego and the San Diego Data Processing Corporation; and

WHEREAS, the RUIS Agreement designates two committees to manage and control the development project; the Management Committee (a Deputy Chief Administrative Officer and an Assistant to the City Manager) and the Policy and Budget Committee (City Manager and County Chief Administrative Officer); and

WHEREAS, the Committees' responsibilities as set forth in the Agreement include, among other things, the determination of fees for use of RUIS, establishing policy regarding sale of RUIS projects to outside organizations and individuals and providing for the distribution of associated revenue; and

WHEREAS, on March 30, 1987, the City Council received a report on the feasibility of installing a City-housed and supervised system that could be leased or used by the private sector for direct on-line access to City information in RUIS and the implications of a direct on-line public access system; and

WHEREAS, City Council actions on March 30, 1987 included, among other things, (a) direction that the Planning Department provide public access to RUIS, and (b) that the RUIS Management

Committee develop procedures for recovering staff and data processing costs associated with on-line access to RUIS. Since March 30, 1987, on-line access to RUIS has been provided by Planning Department via a supervised terminal; and

WHEREAS, the RUIS Management Committee has since prepared guidelines for use in developing the procedures and pricing policy and these were reviewed and approved by the Policy and Budget Committee; and

WHEREAS, on August 4, 1987, the County Board of Supervisors affirmed the RUIS pricing guidelines and procedures presented herein, for implementation on September 1, 1987, and these policies and procedures will be effective September 1, 1987, for both the City and the County, subject to City Council affirmation; and

WHEREAS, the guidelines and procedures are set forth in the City Manager's Report to the Rules Committee of September 16, 1987, recommending therein that the guidelines used in the development of procedures and a pricing policy for public access to information in RUIS be affirmed by City Council; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the guidelines and associated charges established by the Regional Urban Information System (RUIS) Management Committee for public

access to information in the RUIS data bank, as discussed and recommended in the City Manager's Report to the Rules Committee for its September 16, 1987, be and the same is hereby affirmed.
