RESOLUTION NUMBER R- 269367

ADOPTED ON SEP 28 1987

WHEREAS, the City Council by Council Resolution R-260649 adopted May 8, 1984 authorized the City Manager to submit a proposal to the National Football League to host the Super Bowl; and

WHEREAS, said proposal included a guarantee that taxicab rates would be held at the same price level as that which prevailed during the quarter preceding the Super Bowl event; and


WHEREAS, the Super Bowl will be held on San Diego in January 31, 1988; and

WHEREAS, the City Council by Resolution No. R-258573 adopted May 31, 1983 provided for the establishment and computation of the maximum rates of taxicab fare based on an adjusted percentage of the weighted average of fares for a designated quarter; and

WHEREAS, the City Council now desires to stabilize the taxicab rates to be charged during the Super Bowl; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that pursuant to San Diego Municipal Code Section 75.0202(a) and after a duly noticed and open public meeting, the City Council hereby resolves that the City Manager be and he is hereby authorized to place a moratorium on accepting any changes for taxicab rates of fare for the period beginning October 1, 1987 and ending January 31, 1988, thereby retaining in effect the rates of fare established for the quarter ending September 30, 1987.
