ADOPTED ON SEPTEMBER 28, 1987

WHEREAS, the Mayor and City Council have expressed a strong interest in ensuring that The City of San Diego is doing everything possible to maximize the effectiveness of its fight against drug abuse; and

WHEREAS, to further strengthen the effort, a Committee Against Drug Abuse was created by Resolution No. R-267727 adopted on February 17, 1987; and

WHEREAS, said Committee was assigned to examine all facets of the drug problem in San Diego and to prepare a plan of action for City government that will support efforts to reduce drug abuse; and

WHEREAS, an Interim Report has been prepared to inform the Council on the status of Committee activities in its sixth month of operation; and

WHEREAS, certain members of said Committee have resigned, retired or failed to attend committee meetings thereby creating vacancies on the committee; and

WHEREAS, said Committee has made recommended changes in the membership as set forth in Attachment "A" hereto; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:


1. That the Interim Report of the Committee Against Drug Abuse, filed in the Office of the City Clerk as Document No.

~~R269368~~, be and the same is hereby accepted and approved.

2. That Council Policy 000-13 is hereby waived and the roster of members of the Committee Against Drug Abuse be hereby amended to delete, alter and add the names as reflected on the memorandum to the Mayor and City Council from said Committee attached hereto as Attachment "A."

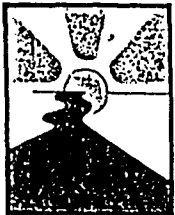

In August 1980 RADM Hacker assumed duties as Commander, U.S. Military Enlistment Processing Command with headquarters in Fort Sheridan, Illinois. In 1982 he reported for duties as Commander Fleet Air Mediterranean; Commander Maritime Surveillance and Reconnaissance Forces, U.S. Sixth Fleet; and Commander Maritime Air Forces Mediterranean, with headquarters in Naples, Italy. He assumed duties as Director, Total Force Training and Education Division (OP-11) on the staff of the Chief of Naval Operations in October 1984. In May 1986, he was awarded an honorary degree of Doctor of Education *honoris causa* by The George Washington University, Washington, D.C.. RADM Hacker became Commander, Naval Training Center, San Diego in August, 1986.

Included among RADM Hacker's personal decorations are the Defense Superior Service Medal, the Legion of Merit with two Gold Stars, and the Meritorious Service Medal.
