RESOLUTION NUMBER R- 269369

ADOPTED ON SEP 28 1987

WHEREAS, the San Diego Association of Governments (SANDAG) adopted the fiscal year 1988 Overall Work Program (OWP) in May 1987 and this report recommends that the program work element for the San Dieguito Regional Open Space Plan be added to the OWP; and

WHEREAS, an essential element in this approach is the establishment of an advisory committee with representatives from the cities of San Diego, Del Mar, Escondido, Poway, and Solana Beach, the County of San Diego, LAFCO, several special districts, property owners, and private and environmental interests; and

WHEREAS, this committee will provide direction and review of the plan as it develops and provide an important first level of agreement about implementation of the completed plan; and

WHEREAS, the Open Space Park Plan is set forth in the SANDAG Agenda Report No. R-63, dated June 26, 1987; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the appointment by the Mayor of The City of San Diego of Councilmembers Abbe Wolfsheimer and Mike Gotch, to serve as the City's elective representatives on the San Dieguito Regional Open Space Park Plan Task Force, be and the same is hereby confirmed.
