WHEREAS, Cerebral Palsy is a disability caused by damage to the brain before or during birth and is outwardly manifested by muscular incoordination and speech disturbance; and

WHEREAS, Cerebral Palsy affects some 12,000 newborn infants each year; and

WHEREAS, some 700,000 children and adults in the United States have Cerebral Palsy, including more than 4,000 residents of San Diego County; and

WHEREAS, the San Diego County affiliate of the United Cerebral Palsy Association provides services to help people who have Cerebral Palsy attain a life of dignity and usefulness; and

WHEREAS, a national telethon, "Weekend with the Stars Telethon for Cerebral Palsy" will be held January 17 and 18, 1988; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council, for and on behalf of all the citizens of San Diego do hereby declare January 23 and 24, 1988 to be "Cerebral Palsy Days" in The City of San Diego and all interested citizens are encouraged to support this worthwhile cause.
