APPROVING MAP OF CARMEL MOUNTAIN RANCH UNIT
NO. 16.

BE IT RESOLVED, by the Council of The City of San Diego, as follows:


That said Council hereby finds that certain map surveyed by Leroy C. Bodas, Registered Civil Engineer, entitled "CARMEL MOUNTAIN RANCH UNIT NO. 16 being a subdivision of a portion of Pompeii Farms Company, Pompeii Subdivision, according to Map No. 1738, filed in the office of the County Recorder of San Diego, September 19, 1922, approval of said map revoked per City Council Resolution No. 203923, adopted October 12, 1971, and a portion of Rancho de los Penasquitos according to map accompanying the patent to said Rancho recorded in Book 2, Page 385 of Patents, in the City of San Diego, County of San Diego, State of California, together with a portion of Windcrest Lane as dedicated to public use," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: Capewood Lane, Seabridge Lane, Windcrest Lane, and Stoney Peak Drive, and said street(s) are hereby declared to be public street(s) and dedicated to the public use, as dedicated and shown on said map and subject to the conditions set forth thereon.

That said Council hereby accepts on behalf of The City of San Diego, the building restricted easement(s) over, upon or across all of Parcel "A," as granted and shown on the map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said street(s) are accepted on behalf of the public as heretofore stated; and the building restricted easement(s), all as granted and shown on the map within this subdivision are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
