BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the low bid of \$313,760.35 by ABC CONSTRUCTION CO., INC., a corporation, meeting specifications for IMPROVEMENT OF EL CAPITAN BOAT LAUNCHING FACILITIES, in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefore in accordance with the form on file in the Office of the City Clerk as Document No. 180209.

2. That the City Auditor and Comptroller is hereby authorized to transfer \$44,930 within the Water Revenue Fund 41502 from the Unallocated Reserve 70679 to the Lake Recreation Construction Program 70393, CIP No. 73-230 ANNUAL ALLOCATION - VARIOUS LAKES.

3. That the expenditure, not to exceed \$44,930 from Water Revenue Fund 41502, CIP No. 73-230 ANNUAL ALLOCATION - VARIOUS LAKES to supplement funds previously authorized by Resolution No. 269084, adopted on August 10, 1987, is hereby authorized solely and exclusively for said project and related costs and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
