

RESOLUTION NUMBER R- 269397

ADOPTED ON SEP 29 1987

WHEREAS, the Planning Commission of The City of San Diego held a public hearing on July 9, 1987, to consider an amendment to the MIRA MESA COMMUNITY PLAN (RAMADA INNS, INC.) for the purpose of redesignating a 6.1-acre site from Industrial Park to Visitor Commercial to allow hotel and associated uses to be developed on the north side of the intersection of Mira Mesa Boulevard and Lusk Boulevard, in the Mira Mesa planning area; and

WHEREAS, the Council of The City of San Diego having considered all maps, exhibits, written documents and materials in this matter, having heard all oral presentations given and being fully advised concerning the same; and

WHEREAS, the Council of The City of San Diego finds that appropriate noise mitigation measures have been incorporated into the project, thus bringing the project into consistency with the Comprehensive Land Use Plan for NAS Miramar; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council hereby approves the amendment of that plan entitled MIRA MESA COMMUNITY PLAN, a copy of which is on file in the office of the City Clerk as Document No. RR-269397, to redesignate a 6.1-acre site from Industrial Park to Visitor Commercial to allow hotel and associated uses to be developed on the north side of the intersection of Mira Mesa Boulevard and Lusk Boulevard.
