RESOLUTION NUMBER R- 269400

WHEREAS, the Planning Commission of The City of San Diego held a public hearing on July 9, 1987, to consider an amendment to the MIRA MESA COMMUNITY PLAN (MARRIOTT CORPORATION) for the purpose of redesignating a 5.6-acre site from Industrial Park to Visitor Commercial to allow hotel and associated uses to be developed on the west side of Scranton Road, between Barnes Canyon Road and Morehouse Drive, in the Mira Mesa planning area; and



BE IT RESOLVED, by the Council of The City of San Diego, that this Council hereby approves the amendment of that plan entitled MIRA MESA COMMUNITY PLAN, a copy of which is on file in the office of the City Clerk as Document No. RR-~~269307~~, to redesignate a 5.6-acre site from Industrial Park to Visitor Commercial to allow hotel and associated uses to be developed on the west side of Scranton Road, between Barnes Canyon Road and Morehouse Drive.
