WHEREAS, it is appropriate to bring the matter to the attention of the City Council for action appropriate toward that objective; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby fully authorized, for and on behalf of said City, to enter into negotiations with the San Ysidro Boys Club Board of Directors for the purchase, by the City, of the San Ysidro Boys Club property and facilities.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller be and he is hereby authorized to expend the sum of \$100,000 for the above acquisition, said funds to come from the 1984 CDBG Program Fund 18520, Department 5813, Organization 1313.

BE IT FURTHER RESOLVED, that Resolution No. R-261920, dated November 13, 1984 be and the same is hereby rescinded.
