HUBBARD CONSTRUCTION, a corporation, meeting specifications for CONSTRUCTION OF SAN YSIDRO BOULEVARD - PHASE I, in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefore in accordance with the form on file in the Office of the City Clerk as Document No. 133098.

2. That the expenditure, not to exceed \$210,000 from CDBG Fund 18523, Dept. 5633, Org. 3304; CIP No. 52-166.1 SAN YSIDRO BOULEVARD - SMYTHE AVENUE TO BORDER VILLAGE ROAD to supplement funds previously authorized by Resolution No. 268878, adopted on July 20, 1987, is hereby authorized solely and exclusively for said project and related costs and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
