BE IT RESOLVED, by the Council of The City of San Diego that the low bid of CARUS CHEMICAL COMPANY meeting specifications is hereby accepted and the City Manager is hereby authorized to execute a contract for the purchase of an ESTIMATED TWO HUNDRED THOUSAND (200,000) POUNDS OF POTASSIUM PERMANGANATE FREE FLOWING CAIROX as may be required for a period of one (1) year beginning November 1, 1987 through October 31, 1988, at a cost of \$1.0845 per pound, for a total estimated cost of \$216,900.00; terms net 30 days, plus sales tax, with options to renew contract for two (2) additional one (1) year periods with a price escalation not to exceed 15% of bid price.

BE IT FURTHER RESOLVED, that the Purchasing Agent is hereby authorized, in the event contractor fails to deliver per delivery schedule, to buy potassium permanganate on the open market on an emergency basis.
