ADOPTED ON OCT 12 1987

BE IT RESOLVED, by the Council of the City of San Diego that the plans and specifications for the furnishing of all labor, material, tools, equipment, transportation and other expense necessary or incidental for MID CITY COMMERCIAL REVITALIZATION PROJECT, PUBLIC IMPROVEMENTS - PHASE II UNIVERSITY AVENUE BETWEEN 30TH STREET AND OHIO STREET, San Diego, California, filed in the office of the City Clerk of the City of San Diego, California, on OCT 12 1987, and bearing official Document No. W.O. 118695, be and the same are hereby approved.

BE IT FURTHER RESOLVED, that the Purchasing Agent of the City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for MID CITY COMMERCIAL REVITALIZATION PROJECT, PUBLIC IMPROVEMENTS - PHASE II UNIVERSITY AVENUE BETWEEN 30TH STREET AND OHIO STREET.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$388,000 (\$174,991 from CDBG Fund No. 18520; \$75,332 from CDBG Fund No. 18521; \$128,177 from CDBG Fund No. 18522 and \$9,500 from Fund 30245, CIP No. 58-007 ANNUAL ALLOCATION - OVERHEAD & OTHER CITY COSTS FOR FEDERAL GRANT PROJECTS) is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
