RESOLUTION NUMBER R- **269424**

ADOPTED ON **OCT 12 1987**

A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO DECLARING ITS INTENTION TO DESIGNATE AN AREA OF BENEFIT IN TIERRASANTA AND SETTING THE TIME AND PLACE FOR HOLDING A PUBLIC HEARING THEREOF.

WHEREAS, the Council of The City of San Diego (the "Council") in Resolution No. R- **266204** stated its intention to initiate proceedings for the designation of a Facilities Benefit Assessment Area of Benefit in Tierrasanta pursuant to Ordinance No. O-15318 of the City (the "Ordinance") which area of benefit will specially benefit from the acquisition, improvement and construction of certain public improvements; and

WHEREAS, the Council on **AUG 05 1986**, designated a Facilities Benefit Assessment District in Tierrasanta and approved the Tierrasanta Public Facilities Financing Plan in Resolution No. R- **266343** (the "Resolution"); and

WHEREAS, the Council in Section 61.2212 of Ordinance No. O-15318 stated that it may annually, after the adoption of the Resolution of Designation and subject to the requirements set forth in Sections 61.2203 through 61.2209 of the Ordinance, cause an adjustment to be made in the Facilities Benefit Assessments established by the resolution; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the Council hereby declares its intention to retain the designation of an area of benefit within Tierrasanta to finance


the cost of the Public Facilities Projects pursuant to the Ordinance.

BE IT FURTHER RESOLVED, that the Council shall hold a public hearing to consider the designation of the Facilities Benefit Assessment Area of Benefit as proposed in this resolution on November 17, 1987, at 10:00 a.m., in the Council Chambers, 202 C Street, San Diego, California.

BE IT FURTHER RESOLVED, that the City Clerk is hereby authorized and directed to give notice of the public hearing described above by publishing this resolution in the Daily Transcript at least two weeks before the date set forth herein and mail copies of this resolution to each owner of property located within the proposed area of benefit at the addresses shown on the last equalized property tax assessment roll, or as otherwise known to the City Clerk pursuant to Section 61.2205 of the Ordinance.
