BE IT RESOLVED, by the Council of The City of San Diego, that the Council hereby declares its intention to retain the designation of an area of benefit within Tierrasanta to finance

the cost of the Public Facilities Projects pursuant to the Ordinance.

BE IT FURTHER RESOLVED, that the Council shall hold a public hearing to consider the designation of the Facilities Benefit Assessment Area of Benefit as proposed in this resolution on November 17, 1987, at 10:00 a.m., in the Council Chambers, 202 C Street, San Diego, California.

BE IT FURTHER RESOLVED, that the City Clerk is hereby authorized and directed to give notice of the public hearing described above by publishing this resolution in the <u>Daily</u>

Transcript at least two weeks before the date set forth herein and mail copies of this resolution to each owner of property located within the proposed area of benefit at the addresses shown on the last equalized property tax assessment roll, or as otherwise known to the City Clerk pursuant to Section 61.2205 of the Ordinance.
