


RESOLUTION NUMBER R- 269432

ADOPTED ON OCT 12 1987

BE IT RESOLVED, by the Council of The City of San Diego, that the acceptance by the City Manager of a street easement deed of ROSECRANS ASSOCIATES, a California limited partnership, executed in favor of The City of San Diego, bearing date of November 6, 1986, a copy of which deed is on file in the Office of the City Clerk as Document No. RR- 269432, granting to said City an easement for public street purposes in Lot B of Pueblo Lot 316, as more particularly described in said deed, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street, and the same is hereby named MIDWAY DRIVE.

BE IT FURTHER RESOLVED, that the City Clerk shall cause the deed and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
