WHEREAS, The City of San Diego is the owner of right-of-way located at the southeast corner of 33rd and F Streets and 33rd and G Streets; and

WHEREAS, the Property Department has requested that the City quitclaim to THE REDEVELOPMENT AGENCY OF THE CITY OF SAN DIEGO, a public body, corporate and politic, its interest in and to said right-of-way; and

WHEREAS, the herein-described property is surplus to City needs; and

WHEREAS, the sale of such an interest in real property as this may reasonably be accomplished by negotiation; and

WHEREAS, the consideration for the right-of-way is the redevelopment of the property; and

WHEREAS, no real estate broker's commission shall be paid; and

WHEREAS, the sale of the aforementioned property is consistent with the public interest; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

- 1. That that certain real property right described in that quitclaim deed on file in the office of the City Clerk as Document No. RR- 269436, be, and the same is hereby determined to be surplus and is hereby authorized to be sold for redevelopment purposes to THE REDEVELOPMENT AGENCY OF THE CITY OF SAN DIEGO.
- 2. That the Mayor and City Clerk of said City be, and they are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a quitclaim deed, which is on file in the office of the City Clerk as Document No. RR
 Quitclaiming to THE REDEVELOPMENT AGENCY OF THE CITY OF SAN DIEGO, that certain right-of-way, as more particularly described in said quitclaim deed.
- 3. That no broker's commission shall be paid by City on the herein described negotiated sale.
- 4. That the City Clerk is hereby authorized and directed to deliver said deed and a certified copy of this resolution, attested by him under seal, to the Property Director for further handling.
