
BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City a third amendment to professional engineering services agreement, with NBS/LOWRY (formerly Neste, Brudin & Stone), for engineering design services for development of the Brown Field Industrial Park Project, under the terms and conditions set forth in the form of a restatement of agreement incorporating the First, Second and proposed Third Amendments thereto, a copy of which is on file in the office of the City Clerk as Document No. RR- **269452** .

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer an amount not to exceed \$17,000 from the Airport Unallocated Reserve Fund (41100) to CIP No. 39-100.

BE IT FURTHER RESOLVED, that the expenditure of an additional amount not to exceed \$17,000 from CIP No. 39-100, is hereby authorized, solely and exclusively for the purpose of providing funds for the execution of the above agreement and further authorizing the City Auditor and Comptroller upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
