- 4. That the City Auditor and Comptroller is hereby authorized to transfer \$207,000 from CIP No. 91-801.3 Fund 18014, GENERAL REVENUE SHARING GENERAL CONTINGENCY FUNDS to CIP No. 34-106, SAN DIEGO JACK MURPHY STADIUM SOUND SYSTEM IMPROVEMENTS.

5. That the expenditure of \$660,000 from Funds 10332, 18014 and 10333, CIP No. 34-106, San Diego Jack Murphy Stadium Sound System Improvements, is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
