WHEREAS, the City Council created [by Resolution No. R-267086, dated November, 18, 1986] an advisory committee to assist with the revision of the Centre City Plan and U.L.I. study; and

WHEREAS, by Resolution No. R-267617, dated February 3, 1987, the Mayor appointed and the Council confirmed thirty (30) persons to serve on this Advisory Committee for Comprehensive Review of the General Plan/Growth Management Program; and
