RESOLUTION NUMBER R- 269472

ADOPTED ON OCT 12 1987

WHEREAS, Tecolote Canyon Natural Park is one of the City of San Diego's most unique open space resources; and

WHEREAS, the Friends of Tecolote Canyon conducted a wildlife habitat enforcement program to protect Least Bell's Vireo nests from overgrowth by the invasive castor bean plant; and

WHEREAS, this program was implemented by volunteers who removed the castor bean plant and replaced it with native vegetation; and

WHEREAS, this effort was facilitated with generous donations needed to purchase the trees, bushes, seed mix and other materials; and

WHEREAS, these donations were made by community members who are dedicated to the enhancement of Tecolote Canyon as a natural park, namely, Mr. John Bogaert of Collins Development who provided \$2,483, George Cramer who provided \$500, and the Friends of Tecolote Canyon who provided \$606; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that this Council extends its gratitude and praise to these donors for

providing the materials necessary to protect and preserve the endangered Least Bell's Vireo, and concurrently enhance Tecolote Canyon Natural Park.
