

RESOLUTION NUMBER R- 269484

ADOPTED ON OCT 19 1987

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the low bid of \$762,044.98 by DALEY CORPORATION, a corporation, meeting specifications for THE IMPROVEMENT OF MIRAMAR ROAD BRIDGE OVER THE ATCHISON, TOPEKA AND SANTA FE RAILROAD in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefore in accordance with the form on file in the Office of the City Clerk as Document No. 118700.

2. That the City Auditor and Comptroller is hereby authorized to transfer \$175,000.00 from CIP No. 37-320 CONVERSION OF PEDESTRIAN SIGNAL HEADS to CIP No. 52-099.4 SORRENTO VALLEY ROAD - SORRENTO VALLEY BOULEVARD TO 3300 FEET NORTHERLY.

3. That the City Auditor and Comptroller is hereby authorized to transfer \$175,000.00 from Capital Outlay Fund 30245, CIP No. 52-099.4 SORRENTO VALLEY ROAD - SORRENTO VALLEY BOULEVARD TO 3300 FEET NORTHERLY to CIP No. 53-042 MIRAMAR ROAD BRIDGE OVER THE SANTA FE RAILROAD.

4. That the expenditure, not to exceed \$175,000.00 from CIP No. 53-042 MIRAMAR ROAD BRIDGE OVER THE SANTA FE RAILROAD to supplement funds previously authorized by Resolution No. 269041, adopted on August 10, 1987, is hereby authorized solely and exclusively for said project and related costs and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
