RESOLUTION NUMBER R- 269495

ADOPTED ON OCT 19 1987

APPROVING MAP OF SOLEDAD WEST VIEW.

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That said Council hereby finds that certain map surveyed by Jacob F. Roth, II, Licensed Land Surveyor, entitled "SOLEDAD WEST VIEW being a subdivision of Lots 1, 2, 39 and 40 in Block 57 of Pacific Beach, according to map thereof No. 933, filed in the office of the County Recorder of San Diego County November 9, 1904, a portion of Acre Lot 23 of Pacific Beach, according to the map thereof No. 854, filed in the office of the County Recorder of San Diego County, September 28, 1898, all in the City of San Diego, County of San Diego, State of California, together with Pendleton Street, Wilbur Avenue and the unnamed alley in Block 57, all as closed and vacated to public use," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: portions of Wilbur Avenue and Loring Street, said portion(s) of street(s) are hereby declared to be portion(s) of public street(s) and dedicated to the public use, as dedicated and shown on said map and subject to the conditions set forth thereon.

That said Council hereby accepts on behalf of The City of San Diego, the easement(s) with the right of ingress and egress for the construction and maintenance of drainage and general utility facilities, as granted and shown on the map within the subdivision.

That said Council hereby accepts on behalf of The City of San Diego, the building restricted easement(s) over, upon or across a portion of Lot 1, as granted and shown on the map and subject to the conditions set forth thereon.


BE IT FURTHER RESOLVED, that the Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said portion(s) of street(s) are accepted on behalf of the public as heretofore stated; together with the easement(s) with the right of ingress and egress for the construction and maintenance of drainage and general utility facilities, as well as the building restricted easement(s), all as granted and shown on the map within this subdivision are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.

BE IT FURTHER RESOLVED, that the City Clerk is hereby directed to record the street vacation of a portion of Wilbur Avenue, Pendleton Street and the unnamed alley approved by Council Resolution No. R-268343, on May 18, 1987, concurrently with the filing of the map.

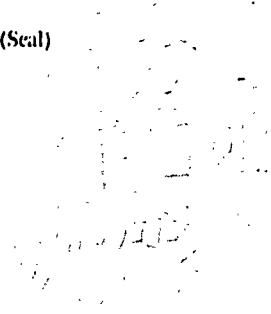
