APPROVING MAP OF VISTA DE ORO.


BE IT RESOLVED, by the Council of The City of San Diego, that said Council hereby finds that certain map surveyed by Charles W. Christensen, Registered Civil Engineer, entitled "VISTA DE ORO being a subdivision of Lots 5 and 6 in Block "A" of Culverwell & Taggart's Addition, according to map thereof No. 249, filed in the office of the County Recorder of San Diego County, January 8, 1870, and the unnumbered lot lying west of 24th Street and north of "A" Street in H. M. Higgins Addition, according to map thereof No. 309, all in the City of San Diego, County of San Diego, State of California, together with those portions of the north half of "A" Street and the east half of 23rd Street as vacated to public use," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map on behalf of the public as heretofore stated.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.

BE IT FURTHER RESOLVED, that the City Clerk is hereby directed to record the street vacation of a portion of 23rd Street, between "A" Street and Russ Boulevard, and a portion of "A" Street, between 23rd and 24th Streets, approved by Council Resolution No. R-257143, adopted September 14, 1982, concurrently with the filing of the map.

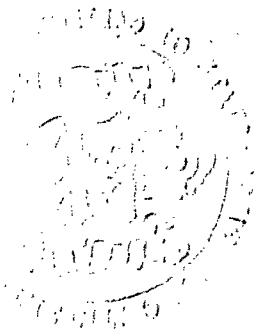
