BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$176,622 from the Sewer Revenue Fund 41506, CIP 46-121.0, Sewer Pump Stations 11, 14 and 16, is hereby

authorized, solely and exclusively for the purpose of providing funds for the above project.
